Submit a video recorded within the last 2 years (since 2023) featuring the actual performers and acts. The video should clearly show the performance you plan to present at this festival.

- ✓ **Video Specifications:** Maximum length of 5 minutes, under 1GB, and playable on standard computers. (Only the first 3 minutes of your performance video will be reviewed.)
- ✓ Submit a YouTube URL or a file transfer service link and ensure it remains accessible until the results are announced.
- Only one application per person or group (no duplicate applications, including solo and group submissions).
- No restrictions on nationality, gender, or professional/amateur status.
- The event may be canceled, postponed, or scaled down due to social circumstances, weather conditions, or other factors. Please note that we are unable to provide any compensation in such cases.
- Participation in other events in Japan during your stay is not allowed.

Performance Rules

- Acts involving public safety risks, animal cruelty, motor vehicles, or promoting religion/politics are prohibited.
- Sales of goods are not allowed.
- Any necessary changes to conditions will be discussed and agreed upon by both parties.
